The NASSCOM Inspire Awards for Non-Tech SMEs is an initiative of the NASSCOM SME Council with the mission to recognize small and medium scale manufacturing enterprises across all industries for their excellence in Tech Adoption.

Manufacturing units (with organizational turnover of < INR 250 Cr.) who have harnessed the transformative potential of technologies to propel growth, improve product/service quality and enhance efficiency in their operational landscape are encouraged to apply.

Under this segment, there are 3 Awards as follows: Best Website (organizational turnover upto INR 25 cr.), Excellence in Technology Adoption (organizational turnover between INR 25cr.& INR 75 cr.), Best Digitalization Initiative (organizational turnover between INR 75cr.& INR 250 cr.)

**General Instructions & Guidelines** 

1. The type of organizations eligible for the award are MSMEs only. The sub-segments of MSMEs eligible for the award shall be as follows:

TYPE I: Organisational Turnover Less than ₹ 25 crores TYPE II: Organisational Turnover ₹ 25 – 75 crores TYPE III: Organisational Turnover ₹ 75 – 250 crores


